(UPDATE: Arrest/Shooting Investigation)

Detectives identify and charge 27 year old Jermel Moss in connection with the February 28, 2017, shooting that sent a 28 year old male victim to the hospital.

On February 28, 2017, at approximately 1:00 a.m. Salisbury police officers and detectives responded to the 500 block of Emory Court, Salisbury, Maryland to investigate a reported shooting. The victim, indicated that he was shot by an unknown suspect.

Further investigation revealed that the 28 year old male victim sustained a serious and potentially life-threatening gunshot wound to his neck. Reports indicate that the victim was operating a vehicle in the area near Middleneck Drive when he was flagged down by the suspect. The victim stopped his vehicle and made contact with the suspect who requested a ride. The suspect then produced a handgun and fired one shot at the victim, striking him in the neck. The suspect fled the area on foot in an unknown direction. The victim also fled the area in his vehicle and traveled to the 500 block of Emory Court where he was transported to Peninsula Regional Medical Center by Salisbury EMS.

Salisbury Police Officers and detectives responded and immediately began a search for the suspect. The search was unsuccessful for the suspect. The victim was treated at Peninsula Regional Medical Center for his injuries and transferred to R. Adams Cowley Shock Trauma Center for additional treatment.

UPDATE

As the investigation unfolded, detectives were able to identify and interview various witnesses and evaluate collected evidence. This investigative effort resulted in the identification of 27 year old Jermel Lee Moss as the person responsible for the early morning shooting of a 28 year old Salisbury man on February 28, 2017. An arrest warrant for Moss was issued on March 02, 2017, charging him with various crimes.

Earlier this morning members of the Capitol Area Regional Fugitive Task Force located Moss in Salisbury and took him into custody without incident. Moss was transported to the Wicomico County Detention Center where he awaits an initial appearance before a District Court Commissioner. The victim remains hospitalized and continues to be treated for his injuries.
